# RESOURCES FOR WORKERS AND BUSINESSES IMPACTED BY THE FRANCIS SCOTT KEY BRIDGE COLLAPSE



### **Resources for Workers**

If you are a Maryland based employee who has been laid-off or working less hours due to the Key Bridge collapse, you may be eligible for Unemployment insurance. The Maryland Department of Labor has created an unemployment insurance hotline for workers affected by the Key Bridge collapse. Please call 667-930-5989 Monday—Friday 8:00 a.m.—5:00 p.m. and Saturday 8:00 a.m.—12:00 p.m.

Online filing is available 24/7 through the Department of Labor's Beacon website, <u>click here</u>. There are instructional videos and other materials to assist.

There is also a mobile unit for in-person options to get help filing a claim, It is located at the Steamship Trade Association, 1901 Portal Street. It is equipped with 14 computer terminals and staffed by the Division of Unemployment Insurance and is open 8:30 a.m.— 4:30 p.m.

Other in-person locations staffed by the Division of
Unemployment Insurance to receive help filing a claim is the
Eastpoint American Job Center in proximity to the Port's
Dundalk terminals has added Division of Unemployment
Insurance staff to assist.

#### **Rapid Response Services**

If you own or operate a business affected by the reduction in Port operations, you may benefit from this service offered by the Maryland Department of Labor. It is tailored to assist workers and businesses to include counseling, job placement support, and regulatory guidance. #### **Economic Injury Disaster Loans**

The Small Business Administration has made Maryland businesses impacted by the bridge collapse eligible for low-interest, long-term <a href="Economic Injury Disaster Loans">Economic Injury Disaster Loans</a> (EIDLs) to help overcome temporary loss of revenue stemming from the bridge collapse. ## Maryland District Court General Information for Evictions— Landlord and Tenant

Visit the MD District Court for housing court matters. <u>Click here</u>

Tenants may have certain rights including:

- The right to know the amount of rent due and have a judge hear any dispute.
- Landlords must keep a ledger of rent charges and payments.
- If the landlord fails to repair a condition on the property that is a threat to life, health, or safety after reasonable notice, a tenant may ask to pay rent into escrow with the Court until repairs are made to the home. The tenant may also ask the Court to reduce the rent.
- Certain landlords must have a license to rent a residential property.
- Tenant may have the right to redeem and stay on the property any time before the actual carrying out of the eviction order by paying past due rent and fees.

We offer programs in the form of grants and deferred loans to perform rehab such as lead removal, disability modifications, HVAC & plumbing, roofing etc.

The programs are as follows:

- Single Family Rehab: A deferred loan home repair program for Baltimore County homeowners that have deficiencies with the interior and exterior of their homes.
- Settlement Expense Loan Program (SELP):
   Provides closing costs and down payment for eligible first time homebuyers.
- Housing Disability Modification Program (HAMP): Disability modification grant program offered to Baltimore County renters and homeowners.
- Lead Safe Program: Lead remediation grant program for Baltimore County houses that were built prior to 1978.
