# Dear League Members,

As we start a new League year, let us exercise our collective voice. The language of democracy is voting. Our League's efforts in voter registration, education, and advocacy empower the residents of Baltimore County to speak this language. We would love to hear all the voices of our members this fall.

Until November, our top priority is *Getting Out the Vote*, (GOTV), for the presidential election. We are pulling out all the stops to provide voters with the information they need to vote. A few of our projects include:

# **ADVOCACY**

### July:

• Our Co-Presidents sent a letter to members of the Board of Education urging support for the election of the **Community Eligibility Provision (CEP) school meal funding option**, which allows eligible schools to provide free breakfast and lunch to all students. This will enable the eligible schools to become *Hunger-Free Schools*.

This was adopted by the Board of Education. In August, 87 schools were brought into the program! These students are eligible for Covid Pandemic EBT (P-EBT) federally funded benefits of \$5.86 per student per day while school facilities are closed.

Our Co-Presidents sent a letter to the County Council in support of Council Resolution No. 76-20
"establishing the Baltimore County Adequate Facilities Ordinance (APFO) Task Force to help the
County adapt to the pressure that growth places on school capacity and for the purpose of providing a
predictable planning environment for the provision of public school facilities by requiring development
projects to pass certain tests as a condition of development approval."

The task force will issue its findings to the County Executive and County Council by November 1<sup>st</sup>. League member Yara Cheikh will represent us on this seven-member task force.




### FOOD INSECURITY IN STUDENT POPULATIONS ACROSS MARYLAND

Laurie Taylor-Mitchell, President, Student Support Network

In a recent study published by No Kid Hungry (and this data is pre-pandemic), 30% of all high school students in Baltimore County now suffer from food insecurity – i.e. they have limited or uncertain access to nutritious food, which is a tremendous stress upon them and their families

The risk of food insecurity for a student of color is more than double that of a white student. See the graphics below from the report <u>FOOD INSECURITY AMONG MIDDLE & HIGH SCHOOL STUDENTS IN MARYLAND</u>, written by Tam Lynne Kelley, Senior Project Manager for No Kid Hungry.

# How are Food Insecurity Rates Different Across the State?



The job losses and economic disaster resulting from the COVID-19 pandemic have worsened hunger and food insecurity across the nation and in Maryland. News from the Student Support Network:

With the schools remaining closed, we will keep distributing food and other essential items at our three distribution sites until Jan. 29, 2021, the day now given by BCPS as the end of online instruction.

We distribute every Friday from 11 a.m. to 1 p.m. Volunteers arrive around 9 a.m. to set up for the distribution and organize the groceries, produce, bread and eggs arriving in trucks and vans, and household items being delivered by volunteers. We are currently assisting about 3,700 people every week, i.e. students and their families. All BCPS students, regardless of where they go to school, and their families, are welcome.

<u>Volunteering at a distribution site is an extraordinary experience</u> (we have strict health protocols and a health monitor at all events, all volunteers are trained before working, and the police are present).

If you or people you know are interested in volunteering, or sorting, and bagging <u>before</u> a site opens, please contact our Executive Director Jess Wodarczyk, <u>execdirector.ssn@gmail.com</u>, to get your or their names into the rotation for a site.



**Good News**: The Community Eligibility Provision will be implemented in 87 schools in BCPS for the next four years! All students attending these County public schools will be offered breakfast and lunch at no charge, ending lunch shaming, meal card debt, and annual paperwork for students and their families, thereby becoming "hunger free schools." About 60,000 students will benefit from this federal program.

# **EDUCATION**

#### **Education - Free meals**

The Community Eligibility Provision allows schools in high poverty areas to serve free breakfast and lunch. A school qualifies for CEP if the percent of students certified for free meals is at least 40%. Eighty-seven schools in Baltimore County qualified for CEP. Parents do not need to fill out free and reduced lunch applications.

Led by education committee member, Yara Cheikh, the Baltimore County League of Women Voters championed the expansion of CEP to feed the poorest children in our schools. The pandemic effects on families have many more needing assistance with basic needs.

# **Adequate Public Facilities:**

Annually the school system conducts a review of overcrowded schools and relief measures in process to mitigate. If a school has a utilization rate of 115%, it is deemed overcrowded. State-Rated Capacity is defined by MSDE and is calculated based on the number of classrooms in the school. SRC applies to the permanent building and does not include relocatable units. Education committee member Yara Cheikh will represent the Baltimore County League on this task force.

<u>AP Fact Check-</u> Associated Press' website, an independent global news organization dedicated to factual reporting, founded in 1846

<u>Fact Check</u>- A project of the Annenberg Public Policy Center

<u>Fact Tank: News in the Numbers</u>- "Pew Research Center is a nonpartisan fact tank that informs the public about the issues, attitudes and trends shaping the world. It conducts public opinion polling, demographic research, media content analysis and other empirical social science research."

<u>MediaBias/Fact Check</u>- A comprehensive media bias resource; currently 3200+ media sources are listed in the database and more are added every day

<u>Media Matters for America</u>- "A web-based, nonprofit research and information center dedicated to comprehensively monitoring, analyzing, and correcting misinformation in the U.S. media."

Open Secrets- Run by the Center for Responsible Politics; non-profit, non-partisan. Also lists where candidates get their money. "Dark Money" is explained in detail.

<u>PunditFact</u>- "A nonprofit project of the Poynter Institute, dedicated to checking the accuracy of claims by pundits, columnists, bloggers, political analysts, the hosts and guests of talk shows, and other members of the media."

<u>SciCheck</u>- Fact Check's site "focuses exclusively on false and misleading scientific claims that are made by partisans to influence public policy. It was launched in January 2015."

<u>Sunlight Foundation</u>- "A national, nonpartisan, nonprofit organization that uses civic technologies, open data, <u>policy analysis</u> and <u>journalism</u> to make our government and politics more accountable and transparent to all."

TinEye- This is a reverse-image search, which tells you whether an image was altered.

Bret Schafer is the Media and Digital Disinformation Fellow at the Alliance for Securing Democracy. As an expert in computational propaganda, he has appeared in *The New York Times, USA Today, The Wall Street Journal*, and *The Washington Post*, and he has been interviewed on NPR, MSNBC, CNN, Al Jazeera, CBS radio, and BBC radio.

Previously, he spent more than ten years in the television and film industry, including stints at Cartoon Network and as a freelance writer for Warner Brothers. He also worked in Budapest as a radio host, in Berlin as a semi-professional baseball player, and in Moscow as an intern in the Public Affairs Section at the U.S. Embassy. He has a master's in public diplomacy from the University of Southern California, where he was the editor-in-chief of *Public Diplomacy Magazine*, and a B.S. in communications with a major in radio/television/film from Northwestern University.
